We are constantly working to improve the Cass County 4-H Fair. As you may or may not know each night during fair week, we provide a variety of entertainment. What you may not know is that very little of the entertainment is free. Two of years ago, we began featuring up and coming country music artists. Money raised from the concerts will be used to upgrade the tractor pull area where the concerts are preformed, the other nightly entertainments, and helping meet the needs of the general fund. We believe that this will continue to be an area that will provide much needed operating funds.

However, as with all endeavors there is a cost involved. As mentioned above the nightly entertainment is a cost to the Fair Association. Donations to the Entertainment Club will help defer these costs and add to the profitability of the concerts.

Through your contribution you are rewarded as well:

- Donations of \$500 – \$999 will receive 2 tickets to the concert and your name on a sign at the fair
- Donations of \$1,000 – \$4,999 will receive 4 tickets to the concert and your name on a sign at the fair and on our schedule
- Donations of \$5,000 and above will receive 6 tickets to the concert and your name on a sign at the fair, on our schedule, and in all of livestock programs
